SELECTMENS ISSUES:

Hazard Mitigation Project: A meeting was held on November 20 at the Town Office. Discussion included how the project will proceed. There will be no cash outlay for the town for this project. The next meeting will be on December 11th.

Rural Fire Water Resource Plan Review: The board has reviewed the plan and has made some suggestions. Anne will compile the suggested changes.

Master Plan: The update is ongoing.

Assessments: The selectmen reviewed the new assessment figures and reviewed the procedure for those who have questions about their assessments. CNP will be scheduling informal reviews with taxpayers as explained in the letter that was mailed to all property owners.

BUDGETS:

Highway: Frank Simpson presented the highway department budget to the board. The budget includes a new line item for Design and Engineer Services. This will be used for assistance with wetland permits and design and cost analysis for projects.

Frank informed the board that the washout on Buffalo Road has grown 2-3feet since he first reported it. The board discussed where the cost of repair would be taken from the budget.

Fire Department: Ken Ward and David Coursey presented the Fire Department budget. There are approximately 23 members on the roster. Discussion included repairs that are needed to Engine 3 and how to cover the cost. It was agreed that the Vehicle Repair and Maintenance line item would be \$3,000, a warrant article would be included in the warrant for \$10,000 to repair Engine 3 and \$10,000 would be placed in the Fire Department Capital Reserve Fund. The \$10,000 that would be placed in the Capital Reserve reflects a decrease of \$5,000.
