SELECTMEN'S MEETING
MINUTES
9/13/2010

The Selectmen, Anne Dow and Frank Simpson met at 6:30 at 330 Groton Hollow Road to look at the driveway with the property owner. A follow-up letter will be sent to the property owner.

Minutes: The Minutes of 8-30-2010 were approved.

Cross Road – Tree/Mailbox: Frank Simpson looked at a dangerous tree located on Cross Road. The tree should be removed for safety reasons however there is a mailbox attached to the tree. A letter will be sent to the property owner concerning this matter and asking them to relocate the mailbox so the tree can be removed.

Galos Subdivision: The Planning Board has reviewed and discussed the subdivision. The Planning Board feels that because this is now a subdivision the subdivision regulations for roads should be followed. The Selectmen agree that a letter should be sent to the property owner by the Planning Board about this.

Highway: Frank Simpson asked for the board's approval to purchase approximately 200 yards of 1 ½" stone at a cost of \$12.00/yard. The board approved the purchase.

Truck Brakes: Bo Beadle met with the board to discuss the use of truck brakes by logging trucks and tractor trailers within the town limits. The brakes are being used early in the morning and late at night. The board has received previous complaints about this. The board discussed the options available including a town ordinance and placing signs in several places. The board will look into this further.

Police Vests: The board reviewed a memo from Chief Main explaining that the PD will be purchasing two bulletproof vests under the federal grant program. 50% of the cost of the vests will be reimbursed to the town.

Baker River Testing: As of September 7, 2010 all readings in the Baker River are normal.

Savoie Requests: William Savoie has requested clarification and assessment information for his property. Anne has called CNP for this information and will follow-up with Mr. Savoie when the information is available.

Junkyard Update: Mr. Kuchinsky notified the board that one more vehicle has been removed and he is continuing to clean up.

Privilege of the Floor: None

Groton Wind:

- Training – The board feels that the Town of Rumney should only negotiate for Rumney and not other towns.
- Draft Agreement – The board reviewed wording in the training section. This will be forwarded to the town attorney for review.
- Department Heads of Emergency Services will meet with Ed Cherian on September 20, 2010.
- The board reviewed a letter from the Rumney Conservation Commission in response to the board's letter to the Commission. The letter is available in the meeting room at the town office if the public would like to review it.

Warren-Wentworth Ambulance Service: The board reviewed a proposal for the 2011 calendar year for ambulance services. The board will discuss this further.

The meeting adjourned at 8:15 pm.
