The meeting was opened at 7:00 p.m.

MINUTES: The minutes of 03/28/11 were accepted as written.

Anthony Reed, Assistant EMS Director, stopped by with a letter he received from Comstar regarding a Medicare Enrollment Application. Anne will look into this week. Also discussed were some unexpected repairs to the ambulance and the purchase of new tires. The Board received another letter from Comstar requesting a "write off" on a delinquent account; the patient actually lives in Groton. Anne will get some more information on this also.

7:15 **A. Lee** met with the Board at her request. The Board voted to go into non-public session under RSA 91-A:3(c) at 7:15 p.m. The Board voted to leave non-public session at 7:25 p.m. No votes were taken.

7:45 **Linda Whitcomb** met again with the Board to discuss the properties that are up for tax deeding. The Board voted to hold off with any deeding until next month.

TIME WARNER - Time Warner has dropped two more channels from their line-up. Many residents are unhappy with these changes and have contacted the office asking for some explanations. There are still residents who do not get any cable or internet service. The Board will send a letter to Time Warner addressing these concerns.

HB 316 – A bill that would remove penalties for taxpayers who fail to fill out property tax inventory forms and refuse to allow property inspections is currently being addressed at the State level. The Board is not in favor of this bill as it could affect our tax rate considerably. They will send a letter to the legislators requesting they vote no on the bill.
